This shall be done via enforcement of the Construction Management Policy, consultation with affected workers and communities and mediation by a site officer who will be appointed by the beginning of construction works.</p> <p>The project will also implement a grievance procedure to enable project affected people to report their concerns and complaints (for any aspect of the project, not just worker related). The procedure will be provided in the public domain and will focus on the timely resolution of issues.</p>		
<p>Medical facilities: Possible impact on the medical infrastructure of the local community.</p>	<p>The construction site will be provided with First-Aid facilities for the personnel according to Russian Legislation requirements. In case of lack or unavailability of the said facilities or due to the number of personnel involved, a specific medical organization will be involved such as the Kstovo branch of “Zdravniza”, a non-state health care establishment which is not related to medical infrastructure of the local community thus minimizing the possible adverse impact.
